About

India Trilateral Forum

The India Trilateral Forum is the leading regular dialogue between Americans, Europeans, and Indians involved in influencing, crafting, and implementing national and foreign policies. Twice each year since 2010, the Forum has convened government officials, intellectuals, media commentators, and business representatives for an intimate conversation on shared political, social, and economic objectives as well as the implications of India's rise for the transatlantic community. The Forum has been held in Europe (Stockholm and London), and in three cities in India (New Delhi, Mumbai, and Bengaluru). In eleven editions over seven years, the Forum has engaged over 250 key individuals, including leading politicians and government officials, influential columnists, representatives from top businesses, and renowned policy experts from India, the United States, and Europe.

Format

The café style format of the forum is designed to create a conversation between peers. While panelists are expected to help lead the conversation, they are only asked to give scene-setting remarks of around 5-7 minutes, preserving the majority of the session for an open back and forth between all of the participants in the room.

India Trilateral Forum is held under the Chatham House Rule, which states that:

When a meeting, or part thereof, is held under the Chatham House Rule, participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed.

Discussion Model

Guidelines for Moderators, Panelists, and Participants

The India Trilateral Forum was created to strengthen networks and understanding between the policy communities of India, the United States, and Europe. Skillfully moderated sessions between experts on the specified topics will maximize the Forum's impact. Here are some rules of thumb to help the Forum accomplish its goal of providing a compelling participatory format.

- The Forum is about creative conversation as opposed to formal presentations.
- The purpose of the Forum is to foster real dialogue that involves all participants in the room. The format does not allow for unplanned formal presentations, speech-making during discussions, or seminar-like presentations.
- No one should prepare to deliver lengthy remarks or a speech of any kind during the panel sessions. Long speeches or remarks would disrupt the proceedings and interrupt what we seek to accomplish.
- Designated moderators should briefly introduce the panel – name and affiliation is sufficient. All panel speakers should keep their opening remarks to five minutes or less. The moderator will not hesitate to intervene if the opening remarks run long.
- The purpose of each discussion is to focus on the trilateral dimension of the topic. All participants are asked to think in the framework of trilateral aspects of each session and topic.
- Designated moderators will be the guides for the open discussion sessions and will be looking for your participation.
- All participants are asked to restate their names and affiliations when they begin to speak for the sake of other participants.
- All participants, as they engage in the discussion, are asked to give succinct observations and questions to allow time for others to contribute.
- Moderators will state explicitly in their sessions that the Chatham House Rule applies. Chatham House Rule is an honor-bound agreement that states, “participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed.”

Biographies

Alka Acharya is professor and former chairperson at the Centre for East Asian Studies (Chinese Studies), School of International Studies, Jawaharlal Nehru University (JNU). She has been teaching courses on Chinese foreign policy and political economy to Masters and M.Phil students, and guiding doctoral research since 1993. From 2012 to 2017, she was on deputation as director and senior fellow at the Institute of Chinese Studies, Delhi. She is joint editor of the book, "Crossing A Bridge of Dreams: 50 years of India-China", has contributed chapters to many books and journals. She was editor of the quarterly journal *China Report* (New Delhi) from 2005 to 2013. She was nominated by the Indian government as a member of the India-China Eminent Persons Group from 2006 to 2008, and member of the National Security Advisory Board of the Government of India for two terms between 2006-2008 and 2011-2012. She has authored a book "China & India: Politics of Incremental Engagement", published in 2008. Her current research focuses on India-China-Russia Trilateral Cooperation and the Chinese strategic response to the post-cold war Asian regional architecture.

H.E. Nicos Anastasiades served in the National Guard, first at the Recruits' Training Centre (KEN) in Larnaca and then at the 4th Higher Military Command. Nicos Anastasiades is a founding member of the Youth of the Democratic Rally (NEDISY), in which he served from the posts of District Secretary, Vice President and President. After his successful term in NEDISY, he takes action next to the historical leader Glafkos Clerides from the positions of First Vice President and later Deputy President until 1997. He is a member of the Cyprus National Council since 1995. Nicos Anastasiades was triumphantly elected as President of the Democratic Rally in 1997, a position that the members and officials of the party firmly trusted him with by being re-elected in 1999, 2003, 2007 and 2012. At the same time, Nicos Anastasiades was elected as Member of the House of Representatives from 1981 until his election to the Presidency of the Republic. Tanvi Madan is director of The India Project and a fellow in the Foreign Policy program at the Brookings Institution in Washington, DC. Dr. Madan's work explores Indian foreign policy, focusing, in particular, on India's relations with China and the United States. She also researches the intersection between Indian energy policies and its foreign and security policies. Dr. Madan is currently working on a book on the U.S.-India relationship and China. Previously she was a Harrington doctoral fellow and teaching assistant at the Lyndon B. From 1995-1998, Mr. Mathai was Ambassador of India in Israel, Qatar, and France from 1998- 2011. He was Foreign Secretary of India for 2 years from 2011-2013. After his retirement he was appointed high commissioner of India to the United Kingdom from 2013-2015. Mr. Mathai completed his education with an M.A in Political Science from the University of Poona (Pune) in 1974. He is an alumnus of the National Defence College in Delhi (27th Course, 1987).

Akshay Mathur is the director of research and a fellow of Geoeconomic Studies. His research focuses on the architecture of international business, finance and trade, and its impact on geopolitics. Before joining Gateway House, he worked as a principal architect

with Fidelity Investments in Boston in the advanced research, strategy formulation, and business architecture. He is the co-founder of an NGO called Aasra Gramin Vikas Sansthan and of a social enterprise called Khushi Farms, both based in Ajmer, Rajasthan, India. He has an MBA from Boston University's Questrom School of Business with concentration in Finance and Business Analysis and research focused on transnational business and global macroeconomics. He has a B.S. in Computer Science from the School of Computer Science at University of Massachusetts, Amherst. Akshay is an alumnus of Mayo College, Ajmer.

Alexander McLachlan is senior advisor in the Strategic Planning Division of the European External Action Service, where he works the implementation of the Global Strategy for the EU's Foreign and Security policy and on Asia Policy. He came to the post after serving as advisor in the Private Office of the Secretary General, and head of the secretariat preparing the EU Foreign Affairs Council. From 2011-2015 he served as Minister Counsellor heading the political and economic section of the EU Delegation to Japan. He was posted to China From 2007-2011 as head of the political section of the EU Delegation to China. Before moving to China Mr. McLachlan worked in the Conflict Prevention and Crisis Management division of the European Commission, where he was involved in the establishment of EU peace and stability operations in Afghanistan, Aceh, Gaza, Kosovo and Iraq. He participated in ECOWAS-mediated peace talks on Liberia and in the design peacebuilding measures in Sri Lanka. Prior to that, he had worked on EU programmes in Central Asia and the Caucasus. Mr. McLachlan began his career in the UK Cabinet Office.

Maya Mirchandani is a senior fellow at Observer Research Foundation, New Delhi. She currently heads the 'Countering Violent Extremism' project (CVE) analyzing hate speech and counter messaging online. Ms. Mirchandani is a broadcast journalist with over two decades of reporting with NDTV. She has reported extensively from Kashmir. Ms. Mirchandani has survived two suicide bomb blasts — in Sri Lanka and the civil war in Sierra Leone. She reported live New York on 9/11 and its immediate aftermath. Ms. Mirchandani has received the Ramnath Goenka Award for Excellence in Journalism twice, and the Exchange for Media Award for 'Best International Affairs Reporting' for her coverage of post-war reconstruction in Sri Lanka. Asoke Mukherji served in the Indian Foreign Service for more 37 years, before retiring from New York as India's Ambassador and Permanent Representative to the United Nations in December 2015. His UN assignment was marked by the remarkably swift implementation in December 2014, within 75 days and with the co-sponsorship of 177 countries, of Prime Minister Narendra Modi's proposal for the UNGA Resolution declaring an International Day of Yoga. He catalyzed the tabling of the unanimous UNGA decision adopting a text for UN Security Council reforms in September

2015. He opened India's embassies in Uzbekistan, Tajikistan and Turkmenistan in 1992 as India's first resident Chargé d'affaires, and was India's Ambassador to Kazakhstan in 2005. He has been India's deputy chief of mission in Moscow, and India's deputy high commissioner to the UK. He has brought out 7 books. His latest book "India and the United Nations: 1945-2015 – a Photo Journey", was presented by Prime Minister Narendra Modi to the UN Secretary General Ban Ki Moon during the 70th anniversary Summit of the United Nations in September 2015.

Anthea Mulakala is The Asia Foundation's director of international development cooperation. From 2007-2014, she served as country representative in Malaysia. Since 2010, she has also led the Foundation's engagement on development effectiveness and aid policy. Between 1991-2006, Ms. Mulakala worked for several multilateral, bilateral and nongovernmental organizations in Asia, including the World Bank (in support of Indonesian decentralization), South Asia Partnership (in support of NGO capacity-building in Sri Lanka and regional gender issues), and the United Kingdom's Department for International Development (DFID), where she led a large health project consortium in Bangladesh and served as DFID's Reconciliation and Development advisor in Sri Lanka. Ms. Mulakala has written and published on conflict dynamics in Asia, aid and development policy, south-south cooperation, Indian development cooperation, and various issues in Malaysian political economy. Ms. Mulakala holds a Bachelor of Arts (B.A. Hons.) in Political Science and English from the University of Western Ontario and a Masters of Arts (M.A.) in International Affairs from the Norman Paterson School of International Affairs at Carleton University in Ottawa, Canada.

Dhiraj Nayyar is officer on special duty and head, economics, finance and commerce, NITI Aayog, Government of India. At NITI Aayog, he is responsible for all policy matters related to the department of economic affairs, department of revenue, department of financial services, department of investment and public asset management and department of commerce. He is secretary of NITI Aayog's committee on loss making public sector enterprises, secretary of NITI Aayog's committee on strategic disinvestment, secretary of NITI Aayog's committee on monitoring the implementation of revival packages in public sector enterprises and member of the spices board. Mr. Nayyar trained as an economist at St. Stephen's College, Delhi, Merton College, Oxford and Trinity College, Cambridge. After a teaching at the University of Cambridge, Mr. Nayyar switched to journalism. He was opinion editor of *The Financial Express*, deputy editor of *India Today*, editor-at-large at Firstpost.com, India columnist for *Bloomberg View* and managing editor of *The Quint*. He was also CEO of the Think India Foundation, a media-active think tank. In 2013, he was awarded a Bastiat Prize in journalism by the California-based Reason Foundation. Ruhee Neog is the director of the Institute of Peace and Conflict Studies, New Delhi, and the head of its Nuclear Security Programme. A foreign and security policy analyst, her

research focuses primarily on nuclear politics and strategy with an emphasis on China, India, Iran, Pakistan, and North Korea. She is currently working on two research projects: Obama's nuclear disarmament legacy and the role of the Indian and Pakistani media in Indo-Pak crises since Kargil. Shruti Pandalai is an associate fellow at the Institute for Defence Studies and Analyses (IDSA), primarily working on issues closely related to India's national security and foreign policy, India's strategic thought and practice, India's military history - the wars of 1962 and '65 and their impact on contemporary foreign policy, emerging challenges to national security and forecasting and scenario projection. Editor of two books – "Indian Ocean Challenges: a Quest for Cooperative Solutions" (2013) and "Geopolitics of the Indo-Pacific" (2014), Abhijit has published papers on India's growing maritime reach, security of sea-lines of communication in the Indo-Pacific region, Indian Ocean governance issues and maritime infrastructure in the Asian littorals. In 2010, Mr. Singh assisted the late Vice Admiral GM Hiranandani (Retd) in the authorship of the third volume of "Indian Naval History, Transition to Guardianship". Prior to joining ORF, he was a research fellow at the Institute for Defence Studies and Analyses at New Delhi.

Sushant Singh is a former military officer with two decades of active service, he is currently the associate editor of *The Indian Express*. A recipient of the UN medal, he has done multiple stints of duty in Jammu and Kashmir, and served with the United Nations in Cote d'Ivoire. He has authored numerous papers and book chapters for global think-tanks on national security and international relations. His book, "Mission Overseas: Daring operations by the Indian military" was released earlier this year.

Jayant Sinha is the Minister of State for Civil Aviation, Government of India. Previously, he was the Minister of State for Finance. He is a member of Indian Parliament and formerly an investment fund manager and management consultant. Prior to his political career, he had a prestigious career in the private sector, making partner at Omidyar Network, Courage Capital, and McKinsey & Company. As a politician, he has served as a member of two important parliamentary committees—the Public Accounts Committee and the Standing Committee on Finance. Alumni of the Harvard Business School, University of Pennsylvania, and Indian Institute of Technology - Delhi, he has over 25 years of experience as an investor and strategy consultant.

Andrew Small is a senior transatlantic fellow with GMF's Asia program. His research focuses on U.S.-China relations, Europe-China relations, Chinese policy in South Asia, and broader developments in China's foreign and economic policy. He was based in GMF's Brussels office for five years, and worked before that as the director of the Foreign Policy Centre's Beijing office, as a visiting fellow at the Chinese Academy of Social Sciences, and an ESU scholar in the office of Senator Edward M. Kennedy. He is the author of the book "The China-Pakistan Axis: Asia's New Geopolitics" published with Hurst / Oxford University Press in 2015.

Shubh Soni is programme coordinator at ORF and supports the organisation's business development and outreach activities. His scope of work cuts across sectors, including global governance, foreign policy, development finance, climate change, and domestic politics. Mr. Soni has assisted in building and strengthening the Foundation's marquee platforms, such as the ORF-MEA Raisina Dialogue on geopolitics and geo-economics, the Asian Forum on Global Governance, and the BRICS Academic Forum. He is also actively involved in creating new and building on existing partnerships with Indian and foreign governments, and a range of non-governmental organizations like the MacArthur Foundation. He has also worked with the development consultancy, IPE Global, at their Delhi office. His dissertation during his masters focused on the trends, policies and determinants of foreign direct investment in India and China.

Sharon Stirling is the senior program officer with GMF's Asia program. In this role, she coordinates the day-to-day running of the program and oversees its annual budget of more than a million dollars. Ms. Stirling manages GMF's Japan portfolio, which includes annual U.S.-Japan-Europe forums: Trilateral Forum Tokyo and Japan Trilateral Forum, a renowned leadership development initiative for mid-career professionals from major democracies called the Young Strategists Forum, and high-level workshops and seminars in Brussels, Berlin, and Washington, DC. She also manages GMF's developing portfolio of work on Southeast Asia, including the Southeast Asia Trilateral Forum, and oversees research products on transatlantic cooperation on a rising Asia. Prior to joining GMF, she was a TV news producer for NHK, Japan's public broadcasting organization. Serving at NHK's bureau in Washington, DC, her assignments included the U.S. State Department, the 2008 presidential election, and the 2008 global financial crisis. Ms. Stirling was born in the

Philippines, spent ten years in Japan, four years in Taiwan, and a year in China, and has traveled extensively in Asia. She graduated magna cum laude from Georgetown's School of Foreign Service.

Robin Sukhia has worked with India since 1996. Through a Swedish Venture Capital firm, he was one of the pioneers in northern Europe to invest in India. He has held board positions in India and Sweden and since 2005, holds the position of secretary general and President of the Sweden-India Business Council (SIBC). In 2016 SIBC and Mr. Sukhia were appointed by the Wallenberg Foundation to be the Secretariat to ISBLRT - India Sweden Business Leaders' Roundtable, which consists of owners, chairmen and CEOs only, of the 30 largest companies in Sweden. Mr. Sukhia advises companies and government institutions in their India related work. He has also been the global business development advisor at risk mitigation firm Vesper Group where he continues to hold an advisory position. Mr. Sukhia holds a Bachelor of Science in business administration from the State University of New York and has briefly studied at Uppsala University's renowned Institution for peace and conflict studies.

Eva Svedling was appointed state secretary to the Minister for International Development Cooperation and Climate, Ms. Isabella Lövin, in the Swedish Government in September 2016. Ms. Svedling is responsible for Swedish Climate Policy. She is a member of the Green Party and prior to her position as state secretary she was head of the Swedish Green Party Parliamentary Secretariat. From 2001-2011, she held a number of positions within the Save the Children Sweden Programme. Previous to that she worked as a consultant for the Swedish International Development Cooperation Agency. Ms. Svedling holds a B.Sc. in Sociology from Stockholm University.

Roger Svensson is a senior fellow at the Institute for Security and Development Policy in Stockholm and Chairman of the Board of the Institute. He also serves as senior advisor to the German Marshall Fund of the United States. For fifteen years he was executive director of the Swedish Foundation for International Co-operation in Research and Higher Education – the STINT Foundation. From 1991-1994 he worked on science policy in the Swedish Ministry of Education and Science; at the end as assistant under-secretary. In the late 1970s and early 1980 he was an expert and consultant to the Directorate on Science, Technology and Industry, OECD. Svensson holds a BA degree in political science and history from Uppsala University and pursued for a few years doctoral studies in modern American history at the same university. He spent 1971-72 at the Charles Warren Center, Harvard University.

Shashi Tharoor is an author, politician, and former international civil servant, Dr. Tharoor straddles several worlds of experience. Currently a second-term Lok Sabha Member of Parliament (MP) representing the Thiruvananthapuram constituency and chairman of the Parliamentary Standing Committee on External Affairs, he has previously served as Minister of State for Human Resource Development and Minister of State for External

Affairs in the Government of India. During his nearly three-decade long prior career at the United Nations, he served as a peacekeeper, refugee worker, and administrator at the highest levels, serving as Under-Secretary General during Kofi Annan's leadership of the organisation. Dr. Tharoor is also an award-winning author of fifteen books of both fiction as well as non-fiction.

Friederike Tschampa heads the political section of the European Union Delegation to India since September 2016, covering the political dimension of India's domestic and external policies, EU-India bilateral relations, particularly foreign and security policy cooperation, as well as coordination with the EU Member States in these areas. Before coming to India, she handled United Nations and Asian human rights issues at the European External Action Service in Brussels. On posting in New York from 2008-2012, Ms. Tschampa contributed to building the EU's new role at the United Nations following the Treaty of Lisbon, focusing on Asia and Europe on the Security Council team as well as peacekeeping and human rights. When joining the EU in 2004, she coordinated the work of the EU Political and Security Committee, the EU Council's main decision making body on Foreign and Security Policy, and later worked on EU-Asia relations. A lawyer by training with a Masters-of-Law degree from the University of London (LSE), Ms. Tschampa also worked at the German Ministry for International Cooperation, the Human Rights Chamber for Bosnia and Herzegovina in Sarajevo, the World Health Organisation in Geneva and Sarajevo, and the German Permanent Mission to the UN in Geneva.

Daniel Twining is counselor and director of the Asia Program at the German Marshall Fund of the United States, based in Washington, DC. As counselor, he serves on the executive management team that governs GMF's \$35 million annual operations in research, convening, leadership development, and grantmaking. As director of the Asia Program, he leads a 15-member team working on the rise of Asia and its implications for the West through a program of convening and research spanning East, South, and Southeast Asia. Dr. Twining previously served as a Member of the U.S. Secretary of State's Policy Planning Staff, as the Foreign Policy Advisor to U.S. Senator John McCain, and as a staff member of the U.S. Trade Representative. He is an Associate of the U.S. National Intelligence Council, has taught at Georgetown University, and served as a military instructor associated with the Naval Postgraduate School. He holds a BA with Highest Distinction from the University of Virginia and MPhil & DPhil degrees from Oxford University, where he was the Fulbright/Oxford Scholar from 2004-07. He writes regular columns for *Nikkei* and *Foreign Policy* and has served as an advisor to six presidential campaigns.

Klaus Vietze is head of division for Africa, Asia-Pacific in the office of the Federal President. Before taking up this position in September 2014 he served as head of the political section of the German Embassy in Beijing. From 2008-2012 he dealt with German-Chinese relations as deputy head of the East Asia Division at the Foreign Office in Berlin. Dr. Vietze joined the German Foreign Service in 1992 after studying Japanology and Economics at Humboldt University Berlin and a postdoc at Harvard University. His postings include EU-

ASEAN coordinator from 1994-1995, German Consulate General in Osaka/Kobe from 1995-1999, desk officer for Japan and the Korean Peninsula from 1999-2000. From 2002-2004 he dealt with IAEA/CTBTO issues at the German Mission to the UN in Vienna before returning to Japan to the German Embassy in Tokyo from 2004-2008.

Ratna Viswanathan is the chief executive officer for the Microfinance Institutions Network. Belonging to the 1987 batch of the Indian Audit and Accounts Service, Ms. Vishwanathan comes with extensive experience across a range of departments of the Government of India including Defense and Prasar Bharti. In the development sector she has served at very senior levels in well-known international NGOs such as Oxfam and VSO. She steered these entities through critical change management processes as they transitioned from international liaison offices to 'full-fledged Indian entities'. Ms. Vishwanathan is a director on the board of Mudra, member of the RBI's Financial Inclusion Advisory Committee and chairperson of the South Asian Microfinance Network.

Erik Widman currently serves as deputy head of the department for Asia and the Pacific of the Swedish Ministry for Foreign Affairs. Prior to that, he was head of division at the department for Security Policy working on European security policy for many years. In this role he was responsible for EU military and civilian crisis management operations and missions and for Swedish participation in major NATO operations. The EU Global Strategy on Foreign and Security Policy and the European Institute of Peace were initiatives which he spearheaded. Mr. Widman has also served at the Swedish embassy in Beijing, where he covered Chinese economic and trade policy, and worked as desk officer for South East Asia at his current department. He began his career as a management consultant at the Boston Consulting Group (BCG). Trained as an economist, he graduated with honors from the Stockholm School of Economics in 1997, and has studied at the London School of Economics, as well as Lewis and Clark College, Oregon, U.S. He is also a graduate of the Swedish Defence Language School, where he learned Russian.

John-Joseph Wilkins is the public information officer at the EU Institute for Security Studies (EUISS). At the EUISS, he works on outreach activities and publications, as well as Strategic Communications and EU-India relations.

Constantino Xavier is a fellow at Carnegie India based in New Delhi. His research interests and publications focus on South Asian security issues and India's foreign policy and relations with its neighboring states, Africa, the European Union, and the diaspora. In 2016, From 2010-2012, Mr. Xavier worked at the Brookings Institution's 21st Century Defense Initiative and The India Project, in Washington DC, and also held research fellowships at the Institute of Defence Studies & Analyses (2010) and the Observer Research Foundation (2014), in New Delhi. While residing in New Delhi (2004-2008) he also worked as a media correspondent covering South Asia and as an adviser to the Embassy of Portugal during the Presidency of the European Union. He remains affiliated as a non-resident research associate for Asia at the Portuguese Institute of International Relations, in Lisbon. Mr.

Xavier has a B.A. in International Relations with studies at Universidade Nova de Lisboa and Sciences Po Paris and M.A. and M.Phil. degrees in International Politics from Jawaharlal Nehru University, New Delhi. Mr. Xavier completed his Ph.D. in South Asian Studies at The Johns Hopkins University, Paul H. Nitze School of Advanced International Studies, in Washington DC.
